BILLING INFORMATION FOR DAYTON CHILDREN'S AND DAYTON PEDIATRIC IMAGING

The following is important information about the TWO BILLS you will receive for the imaging services you are having done today.

Your insurance company will receive two separate bills for your imaging procedure.

- Dayton Children's will bill for performing the imaging procedure. This is the technical component.
- Dayton Pediatric Imaging, Inc. will bill your insurance company for interpreting the image and reporting the results. This is the professional interpretation. Dayton Pediatric Imaging, Inc. is the group of pediatric radiologists located at Dayton Children's.

ATTENTION UNITED HEALTHCARE (UHC) SUBSCRIBERS

Dayton Pediatric Imaging, Inc. does NOT currently have a contract with United HealthCare (UHC). For any services after December 1, 2004, patients insured by UHC will be considered "out of network" for the professional component of the imaging services.

What this means to you:

1. Dayton Pediatric Imaging, Inc. will invoice UHC on your behalf. You do not have to file any paperwork.
2. UHC will process the Dayton Pediatric Imaging, Inc. invoice in accordance with the benefits of the particular UHC plan that you have chosen. In general, one of two outcomes is expected:
 - a. If the policy provides "out of network" benefits, UHC will pay a "usual and customary" fee to Dayton Pediatric Imaging, Inc..
 - b. **If the policy provides no "out of network" benefits, UHC will pay nothing.** Note: UHC may choose to pay YOU, the insured, directly instead of paying Dayton Pediatric Imaging, Inc..
3. Dayton Pediatric Imaging, Inc. will send a billing statement to you after UHC informs Dayton Pediatric Imaging, Inc. of the payment decision.
